

# PAPER PROPERTY CERTIFICATE OF TITLE

## No Longer Prove Ownership of your Property!!!

This is to alert property owners that in 2019 a Parliamentary Bill was passed, rendering all Paper Title Deeds that had ever been issued by the titles office in Queensland void. They no longer have any Legal Status.

*Extract from Land, Explosives and Other Legislation Amendment Bill 2018 - page 268215 Certificates of title cease to be instruments 23 (1) On the commencement, a certificate of title— 24 (a) ceases to be an instrument under this Act; 25 and 26 [s 247]  
(b) ceases to be evidence, conclusive or 1 otherwise, of the indefeasible title for the lot 2 for which it was issued. 3*

Your details are now stored electronically with one of three private companies known as **ELECTRONIC LODGEMENT NETWORK OPERATORS**. As part of the Queensland Futures Fund, a complicated financial arrangement set up by the Palaszczuk government, these three companies are private money making corporations. **Pexa, Purcell Partners Pty Ltd and Simpli Australia Pty Ltd.**

**It appears NO government department will hold the details of your title.**

These companies, like any company may become bankrupt, may be open to security breaches, data theft, lost information, selling of information and more. Human or deliberate error in any Title Registration detail may result in no proof of ownership. And we can only guess at what would happen in the event of the World Wide Web being taken down, as has been implied by the **World Economic Forum**.

**Concurrently the Queensland Titles Registry was made into a private corporation.**

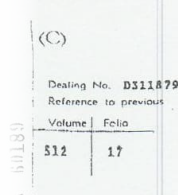
*“While the indirect owners of the Queensland Titles Registry were all government entities as at 30 June 2021, there is no legislative protection under the Queensland Future Fund Act 2020 or the Queensland Future Fund (Titles Registry) Act 2021 to prevent some or all of the holdings in the Queensland Titles Registry from being sold to private entities.” (Queensland Auditors Report).*

In the setting up of Queensland Futures Fund, loans were taken out against Titles Queensland of 2.1 Billion Dollars. The Government auditors had serious concerns about aspects of the Queensland Futures Fund and made recommendations to ensure transparency and public trust.

**NONE OF THESE RECOMMENDATIONS WERE TAKEN UP BY THE QUEENSLAND GOVERNMENT!!**

## OUR QUESTIONS ARE;

- 1. Are our properties used as security for these entities to borrow against?**
- 2. Are titles registered on a server, with no formal title in the owners hands, actually proof of ownership of our properties and how is this legally confirmed?**
- 3. Do changes in legislation and titles office ownership, place us in danger of losing our properties?**
- 4. Does the revenue from land transfers and related fees go into Australian revenue to benefit all Australians or into the coffers of the above listed private entities for the benefit of its share holders?**
